## Announcement of significant change to the voting rights according to the L.3556 - Amendment

This is an amendment of the announcement on significant changes in the voting rights of GR. SARANTIS S.A. dated November 23<sup>rd</sup> 2017.

It is noted that the total percentage of the shareholders' direct and indirect participation in the total shares and voting rights of GR. SARANTIS S.A. remains unchanged compared to the previous notification at 51.997% (i.e. 18,167,087 voting rights).
